### ORAL HEALTH AT CHCS

At Community Health Centers (CHCs) across Maine, oral health care is viewed as an essential part of overall health and well-being. There are strong correlations between good oral health and blood pressure control, diabetes management, and other conditions, reinforcing the important role oral health plays in primary care and behavioral health.

Health centers provide dental care directly at their service sites, or offer a coordinated referral service. In 2022, over 38,000 Mainers received dental services from a CHC. CHCs serve as critical oral health access points to Maine people and are especially vital for uninsured or underinsured individuals. CHCs have a mandate and mission to offer services to all, regardless of insurance or ability to pay, and this extends to dental care.

CHCs employ dentists, dental hygienists, dental therapists and other health care professionals to deliver services. Dental therapists play an important role in expanding the reach of the health center dental care team. They are trained to provide preventive and routine restorative care (filling cavities, placing temporary crowns, some tooth extractions). The addition of dental therapists to dental care teams allows health centers to expand quality care to more patients and provide treatment to more underserved, at-risk populations.

The MPCA team works to support the oral health workforce at Maine CHCs through resources and trainings. A highlight of this is the work being done in the CareerSteps program, in partnership with the Maine Department of Labor. Nineteen Dental Assistants have been enrolled in this training program and three have graduated - several finding employment at a Community Health Center!

#### **Islands Community Medical Center**

In June, the Fish River team celebrated the ongoing construction of a <u>new facility in Madawaska</u> that is slated to open in 2025. The health center began providing part-time services for the area in 2017 and quickly saw that more access to care was needed in the community. Also being celebrated is Fish River CEO Heather Pelletier, who <u>received her Master of Public Health</u> degree from A. T. Still University. This is the fifth degree she has completed with a 4.0 GPA!

#### **Greater Portland Health**

The health center is now operating a <u>new mobile medical van</u>, focused on reducing barriers to accessing harm reduction and substance use disorder treatment options. It will be an extension of outreach clinicians have been doing on foot throughout downtown Portland.


