Have you heard of the 340B Drug Pricing Program? CHCs use this program to get prescription drugs to patients at a lower cost and reinvest the savings into essential health services for the community (think food pantries, transportation assistance, expanded SUD treatment access, etc.). While CHCs exemplify the type of safety net provider 340B was intended to support, the program is unfortunately under attack.
