# **OUTREACH & ENROLLMENT AT CHCS**

Community Health Centers (CHCs) support patients in many ways beyond traditional primary care. This includes outreach and enrollment (O&E) services that help clients access healthcare by connecting them with or guiding them through the process for the Health Insurance Marketplace, Medicare, MaineCare, Social Security, and more. Importantly, O&E specialists are able to help anyone, whether they are a patient or not.

Enrolling in coverage and navigating health plans can be confusing and overwhelming for many people, especially for those experiencing transitions in employment, other life changes, or managing serious or chronic health conditions. O&E specialists at CHCs are a critical resource for many, providing impartial, up-todate information on health insurance options, and often becoming a connector for other supports a person may need (such as food pantries, transportation, and heating or housing assistance).

The health center outreach and enrollment workforce includes enrollment assisters, in-person assisters (IPAs), Certified Application Counselors (CACs), Marketplace Navigators, Community Health Workers (CHWs), and more.

At Maine Primary Care Association, we provide direct support to the individuals within CHCs who do this work and maintain a network of resources outside of the CHCs for referral aid. For more on O&E resources, please contact <u>Carrie Mead</u>, CQI Program Manager.
