# CHC FUNDING INCLUDED IN **CONTINUING RESOLUTION**

Last month, Congress passed a Continuing Resolution to avoid a government shutdown. The bill included an extension of mandatory federal funding for CHCs, National Health Service Corps, and Teaching Health Centers and extended tele-health flexibilities through March 31. CHC discretionary funding is extended through March 14.

## **Fish River Rural Health**



If you miss that deadline, the only way to enroll before the next Open Enrollment (starting November 1, 2025) would be if you experience a qualifying event, such as losing your health coverage, having or adopting a baby, getting married, getting divorced, or becoming a Maine resident.
